Fifth Amendment to Village H Horizon West Road Network Agreement

Ms. Fitzgerald was temporarily unavailable due to some technical difficulties.

Mr. Cooper provided an overview of the Village H construction of Segments 2, 3, and 4 with Segment 2 to be finished first and Segment 4 last. Segment 1 cannot start construction until Orange County completes acquisition of right-of-way. An adjustment of 180 trips from Threshold 3B to Threshold 3A requested for the purpose of funding

Segment 1 construction. County approval of Segment 1 Construction Plans and the submitted bid/construction contract is needed prior to the release of additional trips.

Mr. Sponenburg indicated two of the Segment 1 right-of-way parcels were ready to be closed potentially this week.

Ms. Gines provided an update that the remaining parcel will have an offer made in the near future.

Ms. Fitzgerald re-joined the meeting and asked a follow-up question regarding the conveyance documents. Mr. Cooper asked how much the offer will be for the remaining parcel and Ms. Alfonso stated the information can be provided after the meeting.

Ms. Almodovar asked about the Old YMCA Traffic Signal and whether the signal could be constructed with Segments 2, 3, and 4 instead of waiting for Segment 1 to commence. Mr. Cooper responded that he has requested additional bids and will add the Old YMCA Traffic Signal as a change order to Segments 2, 3, and 4 instead of waiting for the commencement of Segment 1.
