### What's next?





### What is a PDS?

The Orange County Transportation Planning Division is conduction a **Preliminary Design Study (PDS)** to extend New Independence Parkway westward to the Orange/Lake County line in a distance of approximately 1 mile.

The PDS is Orange County's detailed project development process used to evaluate potential roadway improvement options and address anticipated mobility needs of the corridor. In addition, the study will assess both social and environmental impacts associated with the planned road improvement. The proposed improvements are intended to enhance traffic flow and safety in the area. The PDS will provide consistency with the proposed roadway planned in the Lake County (Wellness Way). This portion of New Independence Parkway (NIP) will connect at the existing Avalon Road Intersection and extend NIP west to the Orange/Lake County Line.
