VIRTUAL PUBLIC MEETING

Orange County Transportation Planning Division is conducting a Preliminary Design Study (PDS) to evaluate the addition of travel lanes to the existing 2-lane sections of CR545 (Avalon Road) from south of Hartzog Road to north of Water Spring Boulevard, a distance of approximately 2.6 miles and Flemings Road from the Lake County line east to CR545, a distance of approximately 1 mile.

The PDS is Orange County's detailed project development process used to evaluate potential roadway improvement options and recommendations and address anticipated mobility needs of the corridor. In addition, the study will assess both social and environmental impacts associated with the planned road improvement. The proposed improvements are intended to enhance traffic flow and safety in the area. The County invites you to attend a virtual community meeting to review the preferred alternative under consideration and provide input.

In light of COVID-19, the public meeting will be held virtually over the internet as a free, live presentation on **October 27**, **2021 at 6:00 p.m.** with a welcome from District 1 Commissioner, Nicole H. Wilson, followed by a presentation regarding the study process and the preferred alternative.


