Background

- The Wekiva River and Wekiwa Springs are impaired by nutrients, which cause pollution
- In 2016, the Florida Springs and Aquifer Protection Act updated the Wekiwa Springs and Rock Springs Basin Management Action Plan (BMAP) to require nutrient load reductions
 - Identified septic tanks as the source of 29% of nitrogen in the springs
- Series of meetings with homeowners beginning in 2019
- Construction of Phase 1 (Sweetwater West and Wekiwa Highlands) consisting of 211 lots began in June 2021
- Board of County Commissioners work sessions for Phase 2 on 3/9/2021 and 10/26/2021





 - \$1.722 million approved 5/11/2021
- Legislative Appropriations
 - \$0.500 million approved, effective 7/1/2021
 - Administered by FDEP in the form of a grant
- FDEP Funding Assistance
 - \$0.154 million Sewer Incentives Grant approved 10/2/2020
 - Springs Restoration Program/Water Protection Grant Program
 - Orange County was notified of a multi-phase, multi-year grant including \$3.051 million for Phase 2 on 9/24/2021

Balloting

The Orange County Comptroller has mailed MSBU ballots

- Ballots must be returned by mail and postmarked by 11/29/2021 to be counted
- 67% "In Favor" of project required
- If ballot passes, each homeowner will be responsible for a portion of the project cost as follows:
 - \$6,000 per parcel (paid by homeowner)
 - Cost can be paid up front or financed over a 10-year period through an MSBU
 - If MSBU is utilized, homeowner will pay an annual assessment of \$684.51 for 10 years
 - Includes 2.4% interest rate and \$2.50 annual admin fee
 - Remaining balance may be paid at any time during the 10-year period
 - Assessment is attached to the home itself, not the homeowner (If the house is sold, the assessment is inherited by the new owner)

Enclosed is your ballot for voting on the construction of an Orange County wastewater project in the Palms I and Palms II subdivisions. Homeowners of all benefitting properties are required to contribute to the cost of the wastewater project in the form of a a fixed amount as outlined below. The sum total of the contributions from the homeowners is equal to 10.3% of the project cost. The remainder will be funded by contributions from Crange County Utilities (25%) and multiple state appropriations and grants (64.3%), including the \$2.05 kn kn ker Valler Management District (S.RWMID) and the Florida Department of Environmental Protection (FDEP). The funding structure for the project is detailed in the table below.

OPTION 1: CONSTRUCTION OF A WASTEWATER PROJECT AND ESTABLISHMENT OF A MUNICIPAL SERVICE BENEFIT UNIT

Voting for this option would signify a desire for the construction of a wastewater project to serve the project area and the establishment of an MSBU. The total fixed cost to the OWNER of each benefitting property is \$6,000 and may be either paid in full or financed as presented below.

The designation of the project area as an MSBU allows property owner costs to be amortized (financed) over a 10-year period. The cost would be added to your property real estate tax bill as an annual assessment. The assessment includes interest at 2.4% and a \$2.50 administration fee.

The public hearing would be held during the customary 8:00 a.m. – 5:00 p.m., Monday through friday working house.
