The Orange County Housing Finance Authority (OCHFA) plays a crucial role in promoting affordable homeownership and rental housing for low, moderate, and middle-income families in Central Florida. Below is a summary of OCHFA's recent initiatives and achievements:
Affordable Homeownership Financing: • Investment in Homeownership: OCHEA has allocated \$11 0MM to originate 44 leans, providing assential

Affordable Homeownership Financing: • Investment in Homeownership: OCHFA has allocated \$11.9MM to originate 44-loans, providing essential down-payment assistance totaling \$430K. This initiative aims to empower families to achieve their dream of homeownership. • Bond Issuance: The Authority successfully issued a \$24MM Single-Family Bond Issue, further enhancing its capacity to support affordable housing initiatives.

Mixed-Income Rental Housing: • Financing for Rental Units: OCHFA has dedicated \$135.3MM in Multi-Family Housing Mortgage Revenue Bonds to finance 740-affordable housing units. This effort is vital for expanding and preserving mixed-income rental housing options in the region.

Through these initiatives, OCHFA demonstrates its commitment to improving the quality of life for families in Central Florida by providing access to affordable housing and fostering partnerships that enhance community development.
